- I. Matthew Seifert called the meeting to order
- II. Introduction of Officers and Directors
 - a. President Aric Schneller (absent)
 - b. President Elect Mark Nichols
 - c. Treasurer Heather Mensch
 - d. Secretary Matthew Seifert
 - e. Directors Roland Sandoval, Brent Matthesen, Greg Ball (absent)
 - f. Past Director Alex Parker
- III. Matthew Seifert presented the minutes from the last general session meeting; membership accepted the minutes
- IV. Heather Mensch delivered the Treasurer's Report; membership accepted the report
- V. The board reviewed TMEA, TBA, TJEA Jazz Related Events at the convention
- VI. The board re-announced the 2014 TMEA Invited High School Jazz Band: Southlake Carroll High School; their director, David Lown, was present at the meeting
 - a. There were about 20 great recordings to review
 - b. This year's deadline to submit a recording is May 15, 2014 with a June 15 announcement
- VII. The board announced there will be no TJEA/TMEA endorsed jazz clinician this year there was a process change and we know how to get a clinician in the future
 - a. Frank Coachman offered that there may be an option to have a director session with the Invited High School Jazz Band in its place
- VIII. The board made a general announcement calling for information about jazz festivals, concerts and clinics, articles for the newsletter (John Goode endorsed this), and membership renewal through the website (contact Cathy Benford)
- IX. The board addressed several issues concerning audition etudes and their processes
 - a. The second drum etude (*I'm OK You're OK*) has a different recording due to licensing issues; there was confusion about the click track for the recording because of the half-time section; the track is correct
 - b. On the issue of etude compilation, we didn't realize the enormity of the task; the board proposed a new committee structure for assembling the etudes with four members; all committee members should be fluent in Finale Music Notation Software; we are currently seeking volunteers to fill the following roles:
 - i. A TJEA Director will oversee the process Greg Ball will fill this role for three years and train the newest director in the supervision process in two years
 - ii. An Editor who will review all etudes, keep contact with the composers, submit the documents to a publisher (currently RBC), and work with the TJEA Treasurer to submit invoices
 - iii. Two etude coordinators who collect etudes, clean them up to match one format and submit them to the Editor

- iv. Membership voted to accept the development of a proposal to change the All-State trumpet audition process; this change will endorse the panel to listen to the etudes first, select 10 trumpet players for the All-State Band, then listen to a "lead trumpet" excerpt to select lead players for both bands; top placing auditionees will have the option to play lead in the second band or a lower part in the top band; there is precedent for this in the All-State Band and Orchestra process
- v. Roland Sandoval recommended that all submissions should be in Finale so the engraving process won't take as long
- X. The board announced the October 1st application deadline for a \$250TJEA grant; we have 10 to award and almost always give out more
- XI. The board gave a report of a successful 2013 Jazz Symposium and reluctantly admitted that none of us had been there; nobody in the room had been able to attend either; the primary reason given for not attending was the June 7th date to close to graduation and close-of-year business
- XII. Roland Sandoval updated the membership of his progress with a Texas Jazz Educator's Hall of fame and offered 10 names (attached sheet); five other names were suggested and Roland kept those for submission as well
- XIII. Roland Sandoval continued by asking for submissions for a Texas Jazz Educator of the Year award; he would like the names and bios of each by November 1st
- XIV. Our last order of business was the announcement of the JEN Conference January in Dallas; Jose Diaz gave details of how to submit for performances and highly encouraged a good showing of Texas directors to keep the conference coming back
